Issuance of Permit- If a residential sale is not held on the dates for which the permit is issued or terminated during the first day of the sale because of inclement weather conditions, and an affidavit by the permittee to this effect is submitted, the City Clerk may issue another permit to the Applicant for residential sale to be conducted at the same location within thirty (30) days from the date when the first sale was to be held.

Sales Intervals – No person shall hold, conduct, engage in or participate in any manner or allow residential sale to be held or conducted on premises under his control or ownership more than one time during any three (3) month period.

Signs – Not more than two (2) signs or other devices shall be allowed for the purpose of advertising or otherwise calling attention to the residential sale. One (1) sign may be located not further than the nearest traffic intersection from the sale site and both signs must be located on private property. The display surface shall not exceed four (4) feet. All signs shall be posted no sooner than twenty-four (24) hours prior to the residential sale and must be removed within twenty-four (24) hours of the completion of the residential sale.

Display of Goods – The sale area of any residential sale shall be confined to the premises for which the sale permit has been issued.

Permit Fees – No fee shall be charge for the first two residential sale permits issued to an individual or for a sale site per calendar year. Thereafter a fee of five (\$5.00) dollars per permit shall be paid to the City Clerk at the time of filing the application.

Penalty – Any person who violates the provisions of this Chapter shall, upon conviction thereof, be deemed guilty of an offense and shall pay a fine not to exceed Fifty Dollars (\$50.00) for a first offense, and shall pay a fine not exceeding One Hundred Dollars (\$100.00) for second or subsequent offenses. Every article sold and every day a residential sale is conducted in violation of this Chapter shall be deemed a separate offense.

Warr Acres Garage Sale Tax Submittal Form Instructions

This is a special tax form provided for reporting of garage sale taxes only. If you need to report your business sales tax please contact the Oklahoma Tax Commission for the proper form. Please use a #2 pencil or pen with black ink to make your entries on this form. If you type your report, please type "XXX" over "222" in box P. at the top of the form. This form must be submitted to the Oklahoma Tax Commission by the 20th day of the month following your garage sale to prevent interest and penalties.

SECTION A – Enter your social security number

SECTION B – Enter the month and year during which you held your garage sale.

SECTION C – Enter the due date (Reports must be postmarked on or before the 20th day of the month following your sale).

SECTION D – This section is only used for businesses which have a tax permit issued by the Oklahoma Tax Commission.

SECTION E – Enter your name and mailing address (Name must match social security number).

LINE 1 (TOTAL SALES) - Enter the total amount of gross receipts of all sales.

LINE 2 (REMOVED FROM INVENTORY) – Not used for garage sales tax reporting.

LINE 3 (TOTAL SALES TAX EXEMPTIONS)- Not used for garage sales tax reporting.

LINE 4 (NET TAXABLE SALES) – Copy from LINE 1.

LINE 5 (STATE TAX) - Multiply Line 4 by the current Oklahoma State tax rate (4.5%).

LINE 6 The code entered (5528) designates the municipal tax rate for Warr Acres. Copy LINE 1 number to the boxes in the center of LINE 6.

Multiply this amount by the current municipal tax rate for Warr Acres (4%) and enter that amount in the box at the right.

LINE 14 (TOTAL LINES 6 THROUGH 13) - Copy the amount from the right column of LINE 6.

LINE 15 Not used for garage sales tax reporting.

LINE 16 (TAX DUE) - Add LINE 5 and LINE 14.

LINE 17 (DISCOUNT) - You are only eligible for a 1.25% discount for timely payment. Multiply Line 16 (tax) by .0125. The maximum discount allowed is \$3,300.00. Make no entry if this report is late. No discount allowed for "Direct Pay."

LINE 18 (INTEREST) - If this report and remittance is postmarked after the due date shown in Item C, the tax is subject to interest from the due date (ITEM C) until it is paid. Multiply the amount on Line 16 by .0125 the applicable rate for each month or part thereof that the report is late.

LINE 19 (PENALTY) - If this tax report and remittance is not postmarked within 15 calendar days of the due date, a 10% penalty is due.

Multiply the tax amount on Line 16 by .10 to determine the penalty.

LINE 20 (LESS APPROVED CREDIT) Not used for garage sales tax reporting.

LINE 21 (TOTAL DUE) – Two options may be used here. This is the amount that is to be submitted to the Oklahoma Tax Commission.

OPTION #1 - If filing before due date you may subtract LINE 17 from LINE 16.

OPTION #2 - If filing after the due date add LINE 16, LINE 18 and LINE 19.

PAYMENT INFORMATION - Please send a separate check with each report submitted and put your Taxpayer No. (Item A.) on your check.
